The new illustrations show slight improvement by the removal of the white cladding but little has been changed to significantly alter the style, design and massing. The Council wishes to re-iterate its objections to the previous application and still does not feel that given the prominent position on an elevated hillside that the design of these houses are not in keeping with other prominent buildings such as Oaklands House in either design or materials.
