- Election of Chairman for the year 2016-17: Cllr. Stringer took the Chair for this item. Cllr. Nike was proposed seconded and elected unopposed, and after signing the Declaration of Office took the Chair.
- 2. Declaration of Interests: None
- 3. Apologies for absence: Cllrs, A Vickerman, K. Turner
- **4. Pump Track:** Mr. K. Roberts attended to discuss plans for the proposed Pump Track. He informed the council that:
 - That Saturday would be the worst day for access due to other activities held on Bullholme & Swinden playing fields but it was envisaged that a large tarmac area for basic learning basic cycling skills could be utilised as an overspill car park.
 - 2) That a separate pedestrian walkway under the motorway bridge was being investigated.
 - 3) That road signage would be used for traffic management.
 - 4) That organised sessions and competitions would be charged for but at other times the track would be free to use.
 - 5) That most of the existing trees would remain.
 - 6) That keys to road barriers would be available to the organisers of events.
 - 7) That the project was wholly dependent on acquiring outside funding.

The Council asked Mr. Roberts to investigate and address where possible the following concerns regarding both the proposed track the Stephen Burke Hub. Access to the Stephen Burke Hub was supposed to be from Cravendale Avenue but unless there is an organised event the gates are locked leading to the predominant access being Wilton Street which cannot access the hub because of locked barriers on the access track. This lack of access results in cars and trailers having to park on Bullholme taking the limited parking available for football and cricket and this problem will increase after the construction of the Pump Track.

The Council would like to see meaningful discussions with the current owners of the land that once formed the main access route onto Swinden to re-establish this access particularly on organised events at both the Pump and Stephen Burke track to enable one way ingress and egress onto the sites to prevent two way traffic under the motorway bridge at these events.

- 2) That parking is created opposite the pump track and that the barrier under the motorway bridge is left unlocked to allow users of the cycling facilities who are attending at times other than organised events to park away from Bullholme playing fields.
- 3) That a separate footway under the motorway bridge is essential for public safety.
- 4) That blind spots on some of the access routes be addressed.
- **5. Election of Vice Chairman for the Year 2016-17:** Cllr. Stringer was proposed, seconded and elected unopposed as vice chairman.
