**140. CCTV Monitoring Costs at Nelson & Colne College:** Following a request from Pendle BC to jointly fund the annual running costs of the 6 cameras located around Nelson & Colne College. Cllr. Stringer having asked relevant questions of the Officer dealing with the matter and giving a summary.
