Holmefield House

After 5 years as offices and a monitoring centre for Housing Pendle Holmefield House became vacant and was declared surplus by Pendle Borough Council and was to be offered for sale on the open market. After discussions between the Parish Council and Barrowford Borough Councillors it was decided to try and save the building for public use.

With the support of the Area Committee the Parish Council approached Pendle Borough Council and the first question asked was can we have the building for free, but due to the central government reductions in funding to the Borough this was rejected. The Parish Council negotiated to buy the building for £50,000 a small fraction of its true value.

Holmefield House was signed over to the Parish Council at the end of January and is undergoing extensive refurbishment phased over several years. Around £30,000 of external funding has been found towards these renovation costs with £9,800 from Awards for All and £20,000 from the Area Committee. The first phase of the works is nearing completion and it is hoped that the Luncheon Club will move in before long.

Friends of Holmefield House

It is intended that the community side of Holmefield House will be managed by a group of volunteers with a management committee consisting of predominantly users with a small proportion of parish councillors. An open day is to be arranged for Saturday 9th June from 10am until 3pm. anyone can attend and if you wish to use Holmefield house or be part of the Friends please come along.

Barrowford in Bloom

Barrowford Parish Council in cooperation with the newly formed Barrowford Environmental Action Group and other interested parties entered Barrowford into the 2011 Northwest in Bloom Competition and was awarded a Silver Gilt the second highest award. Interested parties have since formed a fully constituted Barrowford in Bloom group to run this year's entry. The Parish Council will support the group where possible in all their endeavours and feels that these Community Led organisations improve village participation and a sense of belonging to Barrowford. Judging will again take place in July so please help wherever you can.

Christmas Decorations

The decorations for 2011/12 saw no expansion to the scheme as budget reductions at Pendle Borough Council restricted additional expense, but the decorations were again up to the usual high standards.

Allotments

The mania for self sufficiency and "growing your own" still shows no sign of abating with demand for allotments outstripping supply. The current average waiting time for an allotment is has been reduced from last years 9 months for most sites. This has been achieved by splitting larger allotments into two and improving the most neglected plots before offering for let. The upsurge in interest has improved the Council's rental income from allotments in the last

Remembrance Sunday Service

Once again the combined Barrowford Churches Remembrance Sunday Service and Parade was very well attended with the Nelson and District Branch of the Royal British Legion providing both a Standard Bearer and a Parade Marshall. The Parish Council provides the funding for this event and helps with the organisation and logistics on the day and supports the Royal British Legion wherever possible.

Carol Service in the Cruck Barn

The Carol service in the Cruck Barn grows year on year with increasing attendance and is like the Remembrance Sunday a true co-operation between the churches of Barrowford with financial and logistical support from the Parish Council. The Parish Council would like to acknowledge and thank the Heritage Trust for the Northwest for the provision of the barn.

Best Kept Garden Competition

The Best Kept Garden Competition saw its 21st anniversary and continues to grow and goes from strength to strength in both the quantity and quality of the entries. New categories have been introduced over the last few years to make the competition both more open and inclusive to all villagers from a small hanging basket a large formal garden so why not enter? The Council held a presentation night at Barrowford Working Men's Club with around eighty competitors and friends attending. The judge was again Kevin Singleton and he was amazed at the quality or the gardens within Barrowford and the friendly camaraderie and community spirit that was shown at the presentation night and hopes that the competition will continue to be successful for many years.

Friends of Barrowford Park

The Friends Group applied for an Award for All Grant and was awarded £9,047 to create a viewing area overlooking both the salmon ladder and the caul, create a picnic area overlooking the best aspects of the park near the cemetery and do some planting around both the bog garden and memorial garden.

The project has been a close co-operation between the Friends the Parish Council the Parks and the Heritage Centre with the Parish Council undertaking the majority

of the work on behalf of the Friends Group. The viewing area was completed last summer and has proved exceptionally popular both with villagers and visitors. Construction work on the picnic sites has begun and completion is hoped to be by the end of June, with the area also being planted with a wildflower mix to add colour and habitat to the area. It is hoped that all works including planting will be completed by the end of the summer.

Finances 2011-2012

Overview

The continuing financial climate has seen further reductions in funding to both Borough and County Councils coupled with zero community charge increases which continue to put pressure on the non essential services that are provided within Barrowford this has resulted in the closure of the Civic Hall, the loss of the Locality working Officer for Barrowford and the Western Parishes and massive reductions in the funding for the Parks which will increase pressure on the Friends Groups to source funding.

Income

Income for 2011-12 was £131,324.12 with £71,825 being the precept. Allotment rents and water charges provided £7,461.50. Income from interest is still at a very low level compared to a few years ago and looks set to stop low for the foreseeable future. Grants of £45,333 were awarded from outside bodies to the Parish for various projects.

Expenditure

The total expenditure for 2011-12 was £94,093.51 a breakdown can be seen in the balance sheet.
